- o If your business entity registered in D.C., Maryland or Virginia is not in good standing, then we can prepare and file the appropriate documents required to reinstate your entity and bring it back into good standing.
- D.C., Maryland or Virginia Fictitious Business Name Filing (\*) \$530.00
  - All businesses doing business under a name other than their full corporate or LLC name need to register their trade name prior to using it.
- Virginia Registered Agent Service

• Other business matters, including contract review and drafting, commercial lease review and drafting, employment law matters \$530.00/hour

(\*) Our listed fees do not include the District of Columbia Department of Consumer & Regulatory Affairs, Maryland State Department of Assessments and Taxation or Virginia State Corporation Commission filing fees. For forming an entity, these fees vary based upon the number of shares outstanding for an incorporation of a Corporation, and start at \$75.00 for Virginia, \$170.00 for Maryland and \$99.00 for D.C. The fees for organization of a Limited Liability Company are approximately \$100.00 for Virginia, \$150.00 for Maryland and \$99.00 for D.C. The fees for a Fictitious Business Name filing are between \$10 and \$20 depending upon the type of entity for Virginia, \$55 for D.C. and \$75 for Maryland.
